MEMORANDUM CIRCULAR

TO : ALL HEADS OF CONSTITUTIONAL BODIES; DEPARTMENTS, BUREAUS, AND AGENCIES OF THE NATIONAL GOVERNMENT; LOCAL GOVERNMENT UNITS; GOVERNMENT-OWNED AND/OR CONTROLLED CORPORATIONS WITH ORIGINAL CHARTERS; AND STATE UNIVERSITIES AND COLLEGES

SUBJECT : Attendance in the 2012 National Workers' Congress

The **2012 National Workers' Congress (NWC)** with the theme "**Working in Government with Pride and Dignity**" will be held on August 31, 2012 from 8:00 a.m. to 5:00 p.m. at the Tent City, Manila Hotel, Roxas Boulevard, Manila.

Pursuant to the decision of the Public Sector Labor-Management Council (PSLMC) during its meeting on February 10, 2012, the National Workers' Congress (NWC) will be spearheaded by the Presidential Commission on Good Government Employees' Association (PCGGEA) in coordination with the Civil Service Commission (CSC) and the PSLMC.

The 2012 NWC will delve on the following topics: Performance Governance System, Housing, GSIS Benefits and Salary Standardization Law, among others. Also, the election of sectoral representatives to the PSLMC shall be conducted wherein government employees' associations/unions with registered CNAs are entitled to three (3) votes each, accredited unions two (2) votes and registered unions one (1) vote.

Registration Fee is Three Thousand Five Hundred Pesos (P3,500.00) per delegate. However, early registrants can avail of the discount and pay only Three Thousand Pesos (P 3,000.00) per delegate up to June 30, 2012. The payment of said registration fee is exempted from the National Budget Circular (NBC) No. 486 dated March 26, 2003, "Amending National Budget Circular (NBC) No. 442, dated March 29, 1995 Relative to the Cost of Participation of Government Officials and Employees in Conventions, Seminars, Conferences, Symposia and Similar Non-Training Gatherings Sponsored by Non-Government Organizations or Private Institution".

On-line registration are accepted through the NWC2012 Website: www.2012natlworkerscongress.com.ph. Payment of registration fees may be made through any Banco De Oro branch. Delegates from the provinces who will register on-line can get their corresponding official receipts in the venue during the Congress, while on-line registrants from the NCR can pick-up their corresponding official receipts at the PCGGEA Office at the PCGG Head Office in IRC Building, #82 EDSA, Mandaluyong City 1550 or have them delivered to their respective agencies.

Attendance in the said Congress earns an equivalent of four (4) hours of training credited to each participant. Each agency is limited to four (4) participants, preferably three (3) from the union and one (1) from the management. Agency heads are enjoined to support their respective union officers/members who will participate in the 2012 National Workers' Congress.
