: 2019 Public Sector HR Symposium

The Civil Service Commission (CSC) is organizing the conduct of the 2019 Public Sector HR Symposium with the theme, "Moving Together Toward AmBisyon Natin 2040," which will be held on July 24-26, 2019 in Pasay City.

With this year's theme, the HR Symposium highlights the important role of Government Leaders and HR Practitioners in steering public sector organizations and building the capacities of their human resource towards realizing AmBisyon Natin 2040 - Matatag, Maginhawa, at Panatag na Buhay for every Filipino through a People-Centered, Clean, Efficient and Effective Governance (under "Malasakit Pillar or Enhancing the Social Fabric by making government worthy of people's trust" - Philippine Development Plan [PDP] 2017-2022).

The Symposium will showcase global trends and best practices in achieving People-Centered. Clean. Efficient and Effective Governance to include topics on 21st century leaders and HR's skills and competencies; intensifying Public Service Values drive; promoting a culture of innovation and productivity; and harnessing technology to be globally-competitive in today's technology-driven and knowledge-intensive world. It will also include discussions on current measures to achieve seamless public service delivery and anti-corruption drives, enhancing administrative governance, engaging and empowering citizenry, Ease of Doing Business and Efficient Government Service Delivery (EODB EGSD) Act, PRIME-HRM, Results-Based Performance Management (RBPM), Public Finance Management (PFM) and accountability systems.

Leaders, Human Resource Management Officers (HRMOs) and other executives and practitioners from both the public and private sectors are encouraged to participate in the event.

Registration fee is Nine Thousand Six Hundred Pesos (P9,600.00) per participant inclusive of training kits, snacks and lunch during the Symposium, and Certificate of Participation for sixteen (16) hours of leadership and managerial training. Accommodation is not included in the registration fee.
