SUBJECT

Guidelines for Conversion of Positions from Non-Career to Career

Pursuant to CSC Resolution No. 011362 dated August 10, 2001, the Civil Service Commission hereby adopts the following guidelines for conversion of positions from non-career to career:

- 1. Only positions are converted from non-career to career;
- 2. Incumbents of converted non-career positions can be appointed to said positions only if they are qualified and such fact should be specified in the CSC resolution itself; and
- 3. The "vested right" principle should not be applied when positions are converted from non-career to career since it is contrary to the merit and fitness principle.

This Circular takes effect immediately.

RESOLUTION NO. 011362

WHEREAS, the Constitution and the Revised Administrative Code of 1987 mandate that the Civil Service Commission, as the central personnel agency of the Government, shall, among others, establish a career service and strengthen the merit system;

WHEREAS, in pursuance of this mandate, the Commission should strive for a bureaucracy staffed by competent, dedicated and highly professional civil servants;

WHEREAS, there have been continuing requests from various agencies seeking to convert non-career positions to career positions so as to attract highly qualified people with security of tenure;

WHEREAS, the Commission finds such requests conducive to bolstering the constitutional provision affording security of tenure to government employees;

WHEREAS, the Commission in numerous rulings has approved such conversions subject to the condition that the incumbents or would-be appointees to the converted positions meet all the qualification requirements for the position;

WHEREAS, it appears that different interpretations are being given to said rulings;

WHEREFORE, to clarify the matter, the Commission issues the following guidelines for conversions of positions from non-career to career:

- Only positions are converted from non-career to career;
- Incumbents of converted non-career positions can be appointed to said positions only if they are qualified and such fact should be specified in the CSC resolution itself; and

3. The "vested right" principle should not be applied when positions are converted from non-career to career since it is contrary to the merit and fitness principle.
