The annual nationwide undertaking being administered by the CSC through the Honor Awards Program (HAP) aims to recognize and reward individuals and groups of individuals who have rendered outstanding contributions and achievements, and shown exemplary conduct and ethical behavior in the delivery of public service.

Nominations for the Search shall be accepted nationwide through the Civil Service Commission's Regional and Field Offices. Deadline for the submission of nominations is on March 31, 2007.

The following awards shall be bestowed:

- Dangai Ng Bayan Award
- Lingkod Bayan Award; and
- Pagasa Award

The entire bureaucracy is encouraged to participate by way of sending their nominations to the awards program and have their high flyers and public service exemplars be recognized and rewarded.

Enhanced 2007 Guidelines on the Re: **Honor Awards Program** 

RESOLUTION NO. 070105

WHEREAS, the Civil Service Commission as the central personnel agency of the Government, is mandated by the Constitution to adopt measures to promote morale, efficiency, integrity, responsiveness and courtesy in public service as well as strengthen the merit and rewards system;

WHEREAS, pursuant to Executive Order 292 otherwise known as the Administrative Code of 1987, Executive Order No. 508, s. 1992, as amended by Executive Order No. 77, s. 1993, and Republic Act 6713, the Civil Service Commission administers an annual, nationwide awards program for public officials and employees who with be conferred with the Lingkod Bayan Award, Dangal ng Bayan Award and Pagasa Award;

WHEREAS, CSC Resolution No. 060001 dated January 03, 2006 provides for the implementation of the Honor Awards Program;

WHEREAS, enhancement and clarification of certain provisions of the guidelines relative to nomination requirements, procedures and qualifications are needed in order to simplify the nomination and evaluation processes;

WHEREFORE, the Commission resolves, as it hereby resolved, to amend and revise CSC Resolution No. 060001 dated January 03, 2006, and adopt the attached 2007 Guidelines on the Honor Awards Program to govern the conduct and implementation of this year's Search.
