ANNOUNCEMENT

With reference to Examination Announcement Nos. 01, 02, and 03, all dated 08 February 2024, on the simultaneous conduct of the 02 June 2024 FOE, POE, and BCLTE, respectively, below are updates on the testing centers to be used in Regions V, IX and XII, to wit:.

1. Legazpi City shall only be the testing center to be used in Region V for the 02 June 2024 FOE, POE, and BCLTE;
2. Pagadian City shall be included as an additional testing center in Region IX for the 02 June 2024 FOE, POE, and BCLTE; and
3. Koronadal City shall only be the testing center to be used in Region XII for the 02 June 2024 FOE.
