Examination Results

The results (List of Passers) of the May 21, 2017 CSE-FSO have been released and posted on the CSC website www.csc.gov.ph | Examination Results.

Only the List of Passers posted on the CSC website is official. The CSC does not recognize and is not liable for any other postings on any other websites.

A. Individual Examination Result/Rating

Examinees, both passed and failed, may generate their individual test result using the Online Civil Service Examination Result Generation System (OCSERGS), which can be accessed also through the CSC website. To use this system, the examinee should encode/fill in the required data in the corresponding data fields accurately, following the proper format. Successful data submission will produce a copy of the examinee's rating, on screen, which can be printed for reference. Test result generation through OCSERGS shall be available by July 16, 2017. Please note that no report of rating shall be mailed to individual examinees.

Should individual test result generation be unsuccessful despite input of complete and accurate data, and should there be any other concerns on examination result including queries on examinee number, examinees should verify directly with the CSC Regional Office (CSCRO) concerned. The CSC Regional Offices handle the releasing of examination results. A complete directory of the CSCROs is available also at the CSC website through the link http://excell.csc.gov.ph/cscweb/dir ro.html for reference.

B. Certification of Eligibility for Passers on CSC Letterhead

Passers shall be issued a Certification of Eligibility printed on CSC official letterhead, free of charge, by Aug. 2, 2017. The letterhead printed Certification shall be issued through the CSC Regional Offices.

B.1 Issuance and Claiming of Certification of Eligibility

Passers are strongly advised to coordinate and verify first the availability of their Certification before going to the CSC Regional/Field Office. Please access the link http://excell.csc.gov.ph/cscweb/dir_ro.html for the directory of the CSC Regional/Field Offices.

Passers must personally claim their Certification of Eligibility at the CSC RO concerned. Representatives are not allowed to claim on behalf of the passers. In claiming the Certification, passers must present the following items:

1. At least one of the following accepted I.D. cards which must be valid (i.e. not expired) upon claiming of the Certification:

Driver's License; Passport; PRC License; SSS I.D.; GSIS I.D. (UMID); Voter's I.D.; BIR I.D. (ATM type/TIN card type with picture); PhilHealth I.D. (must contain the holder's name, clear picture, signature and PhilHealth number), Company/Office I.D.; School I.D. (validated for the current school year/semester/trimester); Police Clearance/Police Clearance Certificate; Postal I.D.; Barangay I.D.; or NBI Clearance. Any other ID card not included in the above list shall NOT be accepted.

2. Application receipt, if available.

Note: The CSC Regional/Field Offices may require additional document/s as necessary to establish the identity of the passers.

B.2 Claiming of Certification of Eligibility at Conduit CSC RO/FO

In case of passers who have moved to/are based in another region, or in remote areas within the region, they may personally claim their Certification of Eligibility at the CSC Regional or Field Office (conduit CSC RO/FO) nearest their present place of residence or work.

To facilitate the matter, they must send a written request to the authorized CSC RO with jurisdiction over the testing center/venue where they took the examination to forward their Certification of Eligibility to the conduit CSC Regional/Field Office where they would like to claim the same. In their written request, they must also cite their reasons for the request.

C. Certification of Eligibility for Passers on Security Paper

Apart from the letterhead printed Certification, passers may also opt to apply for regular Certification of Eligibility that is printed on security paper at cost (Note: Applying for regular Certification has a different set of requirements and procedures. Please verify with the CSC RO concerned). The security paper printed Certification may be more preferred by government agencies as supporting document for employment application, including promotion and other human resource movements.
