## **PSLMC RESOLUTION**

WHEREAS, PSLMC Resolution No. 1¹, as amended by PSLMC Resolution No. 3², provides that eight (8) employees representing the National Government Agencies (NGAs), Local Government Units (LGUs), State Universities and Colleges (SUCs) and Government Owned and Controlled Corporations (GOCCs) may sit as observers for a term not exceeding three (3) years in the deliberations of the Public Sector Labor-Management Council (PSLMC);

**WHEREAS**, the respective terms of office of the sectoral representatives elected in the 2012 National Workers' Congress had effectively ended on August 31, 2015;

WHEREAS, PSLMC Resolution No. 1 provides that the process of election of employees' representatives shall be decided by the existing employee organizations themselves through a Congress duly called for the purpose;

WHEREAS, on September 10, 2015, through PSLMC Resolution No. 6, the Sweepstakes Employees Union (SEU) was officially designated to spearhead the organization and conduct of the 2015 National Workers' Congress not later than November 2015;

WHEREAS, on November 23, 2015, the SEU, represented by its President, Mr. Christopher C. Bautista, citing time constraints in the preparation for this national event, requested the PSLMC's approval on their proposed postponement of the holding thereof not later than June 2016; and

WHEREAS, finding the above request to be meritorious, the PSLMC interposes no objection thereto.
