## **PSLMC RESOLUTION**

WHEREAS, the PSLMC, in its Resolution No. 1, s. 2001, institutionalized the participation of four (4) sectoral representatives representing the National Government Agencies (NGAs), Local Government Units (LGUs), State Universities and Colleges (SUCs) and Government Owned and Controlled Corporations (GOCCs) in an observer capacity during its deliberations for a term of three (3) years;

WHEREAS, the Council, in its Resolution No. 3, s. 2007 dated July 24, 2007, approved the increase of sectoral representation from four (4) representatives to eight (8) representatives to strengthen participation during PSLMC deliberations;

WHEREAS, the Council recognizes the significant role of said sectoral representatives by actively participating in its deliberations which proves useful in the promulgation of well-informed opinions and decisions of the PSLMC;

WHEREAS, the term of office of the eight (8) sectoral representatives elected in the 2012 National Workers' Congress will end on December 31, 2015 but no successors have been elected yet pending the conduct of a National Workers' Congress where the next set of sectoral representatives shall be elected;

WHEREAS, the Council deemed it in the interest of the service to extend the term of office of the eight (8) incumbent sectoral representatives for the continuous representation of government employees in the PSLMC.

WHEREFORE, the Council RESOLVES, as it hereby RESOLVED, to allow the eight (8) sectoral representatives elected during the National Workers Congress on August 31, 2012 to continue participating in an observer capacity during PSLMC meetings until such time that the next set of sectoral representatives are duly elected in the forthcoming National Workers' Congress.

RESOLVED finally that the extended term of the incumbent sectoral representatives shall not go beyond June 30, 2016.
