EXTENSION OF THE HOLD-OVER CAPACITY OF INCUMBENT PUBLIC SECTOR REPRESENTATIVES IN THE PUBLIC SECTOR LABOR-MANAGEMENT COUNCIL (PSLMC)

PSLMC RESOLUTION

WHEREAS, the participation of the Public Sector Representatives representing the National Government Agencies (NGAs), Local Government Units (LGUs), State Universities and Colleges (SUCs) and Government Owned or Controlled Corporations (GOCCs), in an observer capacity for a term of three (3) years, was institutionalized during its deliberations through PSLMC Resolution No. 2, s. 2001¹;

WHEREAS, the term of office of the eight (8) Public Sector Representatives elected in the 2012 National Workers' Congress has ended on December 31, 2015;

WHEREAS, no National Workers' Congress was conducted since December 31, 2015 or after the expiration of the terms of the incumbent Public Sector Representatives;

WHEREAS, pending the election of new set of Public Sector Representatives, the PSLMC, in its Resolution No. 2, s. 2016², extended the term of office, in hold-over capacities of the eight (8) incumbent Public Sector Representatives from January 1, 2016 to June 30, 2016;

WHEREAS, the extension of term granted by the Council has ended on June 30, 2016;

WHEREAS, the National Workers' Congress will be held on November 28 to November 29, 2016;

WHEREAS, the Council deemed it necessary to again extend the term of office of the eight (8) incumbent Public Sector Representatives for the purpose of conducting the National Workers' Congress.

WHEREFORE, the Council RESOLVES, as it hereby RESOLVED, to extend the term of the eight (8) Public Sector Representatives elected during the National Workers Congress on August 31, 2012 from July 2016 to December 31,
