PARTICIPATION OF THE SECTORAL REPRESENTATIVES DURING DELIBERATIONS OF THE PUBLIC SECTOR LABOR-MANAGEMENT COUNCIL – TECHNICAL WORKING GROUP (PSLMC-TWG)

PSLMC RESOLUTION

WHEREAS, Section 15 of Executive Order No. 180, constituted the Public Sector Labor-Management Council (PSLMC) to implement the policy of the State on the exercise of the right of government employees to self-organization, primarily through the promulgation of necessary rules and regulations;

WHEREAS, on April 23, 2001, the Council promulgated PSLMC Resolution No. 1, s. 2001 which officially recognizes the Sectoral Representatives of the employees' associations from the four sectors of the government bureaucracy namely: National Government Agencies (NGAs); Local Government Units (LGUs); State Universities and Colleges (SUCs); and Government Owned and Controlled Corporations/Government Financial Institutions (GOCCs/GFIs);

WHEREAS, in the aforesaid PSLMC Resolution, the Council allowed one (1) representative from each of the four (4) sectors in the government bureaucracy to sit as observer during Council meetings;

WHEREAS, on July 24, 2007, the Council promulgated PSLMC Resolution No. 3, s. 2007, increasing the number of sectoral representation to attend in Council meetings to two (2) employees' representatives from each of the four (4) sectors of government employees maintaining their observer capacity with no voting rights;

WHEREAS, in the past years, the Sectoral Representatives sat not only during Council meetings but also during deliberations of the Technical Working Group (TWG) where cases and policies are carefully and exhaustively evaluated;

WHEREAS, matters discussed and deliberated during the TWG meetings are submitted to the Council members for their final decision and instructions;

WHEREAS, the sectoral representatives' active participation in the TWG deliberations proved useful in the promulgation of opinions and decisions of the PSLMC;

WHEREFORE, the Council hereby RESOLVES to allow participation of the Sectoral Representatives only during the PSLMC-Technical Working Group meetings where they can actively participate during its deliberations for the drafting of resolutions and decisions to be submitted to the Council for approval.

This Resolution shall take effect immediately upon its approval.
