**SUBJECT :** Inclusion of Government Employees Who Are in 3rd Year College of Studies To the Local Scholarship Program for Bachelor's Degree Completion (LSP-BDC)

The Commission, by virtue of CSC Resolution No. 00-1046 dated April 27, 2000, expands the scope of the Local Scholarship Program for Bachelor's Degree Completion (LSP-BDC) to include undergraduate government employees who completed only second year college studies or are in third year college to participate in the program starting SY 2001-2002.

All heads of departments/agencies are enjoined to inform and encourage their personnel to participate in LSP-BDC for their personal and career growth in government thus enhancing professionalism in the civil service.

CSC RESOLUTION No. 001046

**WHEREAS**, to give equal opportunities for college undergraduate employees in the government, the Commission established the Local Scholarship Program for Bachelor's Degree Completion (LSP-BDC) pursuant to CSC Resolution No. 96-7300 issued on November 18, 1996;

**WHEREAS**, the Commission, under its LSP-BDC offers a one-year scholarship grant to employees who need only one more year of study to obtain a college degree;

**WHEREAS**, there is a limited number of employees who meet the scholarship requirements;

**WHEREAS**, there is also a need to maximize the P20 Million budget allotted for the Local Scholarship Program (LSP) this year;

**NOW THEREFORE**, the Commission **RESOLVES** to expand the coverage of the LSP-BDC by allowing government employees who are in the third year college studies to participate in the LSP-BDC starting SY 2001-2002.

**RESOLVED FURTHER** that the first one-year of studies of the grantees shall be on his/her own time at the expense of the Commission. If the grantee gets an average rating of B, 2, 85 or any of its equivalents, the scholar shall pursue the grant on official time for the second year of scholarship. Henceforth, no further extension shall be allowed.

This Resolution shall take effect immediately.
