## Invitation to Bid for Earthworks and Construction of Two-Storey CSC Field Office-Agusan Del Norte Building [Caraga ITB 2018-01]

- 1. The Civil Service Commission-Caraga, through the Bids and Awards Committee <sup>3</sup> intends to apply the sum of Four Million Eight Hundred Fifty Thousand Pesos (Php 4,850,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for ITB No. 2018-01. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Civil Service Commission-Caraga now invites bids for Earthworks and Construction of Two-Storey CSC Field Office-Agusan del Norte Building, Abilan, Buenavista, Agusan del Norte.<sup>5</sup> Completion of the Works is required 240 calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."
  - Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
- 4. Interested bidders may obtain further information from Civil Service Commission Caraga and inspect the Bidding Documents at the address given below from 8:00 AM to 5:00 PM Monday to Friday.
- 5. A complete set of Bidding Documents may be acquired by interested bidders on February 20, 2018 from the address below in the amount of Php 5,000.00.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- 6. The Civil Service Commission-Caraga will hold a Pre-Bid Conference<sup>6</sup> on March 1, 2018, 2:00 PM at CSC HRD Center, CSC Regional Office, Doongan Road, Butuan City, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat at the address below on or before *March 13*, 2018 at 5:00 PM. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on *March 14, 2018, 10:00 AM* at *CSC - HRD Center, CSC Regional Office, Doongan Road, Butuan City.* Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

- 8. The *Civil Service Commission-Caraga* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
