**RECOMMENDING THE AWARD OF CONTRACT TO 8 DIMENSIONS TRADING AND SUPPLIES, INC. FOR THE SUPPLY AND DELIVERY OF MATERIALS FOR REPAIR OF PERIMETER LIGHTS DAMAGED BY TYPHOON AND ONGOING TRIMMING OF TREES UNDER ABSTRACT OF QUOTATIONS NO. 2023-088 - NEGOTIATED PROCUREMENT – SMALL VALUE PROCUREMENT (NP-SVP)**

**BAC RESOLUTION No. 2023-088 (AMP)**

**WHEREAS**, the Civil Service Commission (CSC) – Office for Financial and Assets Management – Office for Financial and Assets Management - Building and Grounds Management Division (OFAM-BGMD) submitted Purchase Request (PR) which was later numbered by the OFAM-Procurement Management Division (OFAM-PMD) with PR No. 2023-04-0555 for the *Supply and Delivery Of Materials For Repair Of Perimeter Lights Damaged By Typhoon And Ongoing Trimming Of Trees* under mode of procurement **Negotiated Procurement – Small Value Procurement (NP-SVP)** with an Approved Budget for the Contract (ABC) amounting to One Hundred Sixty Five Thousand Pesos (PhP165,000.00). The 2023 approved Annual Procurement Plan (APP) and Certificate of Availability of Funds No. 2023-05-070 are likewise submitted. Copies of the said PR, CAF, and 2023 APP are attached and marked as **Annexes “A”, “B”, and “C”** respectively, and are made integral parts hereof;

**WHEREAS**, NP-SVP of Annex “H” of the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184 or the Government Procurement Reform Act reads: *“The BAC shall prepare and send RFQs/RFPs to at least three (3) suppliers, contractors or consultants of known qualifications. This, notwithstanding, those who responded through any of the required postings shall be allowed to participate. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof;*

**WHEREAS**, the CSC Bids and Awards Committee (BAC), through the BAC Secretariat, posted Request for Quotation (RFQ) No. 2023-088 NP-SVP at the Philippine Government Electronic Procurement System (PhilGEPS), CSC Website, and conspicuous places within the CSC premises starting from 19 May 2023. The RFQ and proof of postings are attached and marked as **Annexes “D”, “E”, “F” and “G”** respectively, and are made integral parts hereof;

**WHEREAS**, the OFAM-PMD likewise conducted canvass of prices by sending RFQ No. 2023-088 NP-SVP to forty-two (42) prospective suppliers/service providers. The proof of invitation is herein attached and marked as **Annex “H”** and made as an integral part hereof;

**WHEREAS**, within the set deadline on 29 May 2023 at 03:00 P.M., five (5) quotations were received by the BAC Secretariat, to wit;

1. A5-Unisol Trading;
2. 8 Dimensions Trading and Supplies, Inc;
3. Arrow Electrical Supply;
4. Illuminix General Merchandise Co.; and
5. Remitechs Electrical Services.

The quotations received are hereto attached and marked as **Annex "I1 to I5"**, and are made integral parts hereof;

**WHEREAS**, upon evaluation of bid/quotation, the CSC-BAC found that **8 Dimensions Trading and Supplies, Inc.** registered under PhilGEPS Registration No. **2015031309261698540448**, offered the lowest calculated and responsive bid amounting to One Hundred Sixty-One Thousand Eight Hundred Fifty Pesos (PhP161,850.00). A copy of the Abstract of Quotation is hereto attached and marked as **Annex "J"** and made as an integral part hereof;

**WHEREAS**, NP-SVP of Annex "H" of the 2016 RIRR of Republic Act No. 9184 or the Government Procurement Reform Act reads: "*the BAC shall recommend to the HoPE the award of contract in favor of the supplier or contractor with the Single or Lowest Calculated and Responsive Quotation.*";

**NOW, THEREFORE**, the Bids and Awards Committee hereby **RESOLVES** to recommend to the Commission, through Chairperson Karlo A. B. Nograles, as the Head of the Procuring Entity, for consideration and approval, the award of contract to **8 Dimensions Trading and Supplies, Inc.** as the Lowest Calculated and Responsive Bidder/Supplier for the *Supply and Delivery Of Materials For Repair Of Perimeter Lights Damaged By Typhoon And Ongoing Trimming Of Trees* amounting to One Hundred Sixty-One Thousand Eight Hundred Fifty Pesos (PhP161,850.00) inclusive of all applicable taxes.
