**RECOMMENDING THE AWARD OF CONTRACT TO RFMARU INDUSTRIAL DESIGN AND FABRICATION FOR THE SUPPLY, DELIVERY AND INSTALLATION OF TWO (2) UNITS HEAVY-DUTY COLLAPSIBLE TENT UNDER ABSTRACT OF QUOTATIONS NO. 2023-219 - NEGOTIATED PROCUREMENT – SMALL VALUE PROCUREMENT (NP-SVP)**

**BAC RESOLUTION No. 2023-087 (AMP)**

**WHEREAS**, the Civil Service Commission (CSC) – Office for Financial and Assets Management – General Services Division (OFAM-GSD) submitted a Purchase Request (PR) later numbered as PR No. 2023-10-1425 for the *Supply, Delivery, and Installation of Two (2) Units Heavy-Duty Collapsible Tent* under the mode of procurement **Negotiated Procurement – Small Value Procurement (NP-SVP)** with an Approved Budget for the Contract (ABC) amounting to **Ninety Thousand Pesos (PhP90,000.00)**. The approved 2023 Annual Procurement Plan (APP), Certificate of Availability of Funds (CAF) No. 2023-10-191, and Tent Layout are likewise submitted. Copies of the said PR, 2023 APP, CAF, and Tent Layout are attached and marked as **Annexes “A”, “B”, “C”, and “D”**, respectively, and are made integral parts hereof;

**WHEREAS**, NP-SVP of Annex “H” of the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act (R.A.) No. 9184 or the Government Procurement Reform Act reads: *“The BAC shall prepare and send RFQs/RFPs to at least three (3) suppliers, contractors or consultants of known qualifications. This, notwithstanding, those who responded through any of the required postings shall be allowed to participate. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof;*

**WHEREAS**, the CSC Bids and Awards Committee (BAC), through the BAC Secretariat, posted Request for Quotation (RFQ) No. 2023-219 NP-SVP at the Philippine Government Electronic Procurement System (PhilGEPS), CSC Website, and conspicuous places within the CSC premises starting 04 October 2023. The RFQ and proof of postings are attached and marked as **Annexes “E”, “F”, “G”, and “H”**, respectively, and are made integral parts hereof;

**WHEREAS**, the BAC Secretariat likewise conducted canvass of prices by sending RFQ No. 2023-219 NP-SVP to four (4) prospective bidders/suppliers/service providers. The proof of invitation is herein attached and marked as **Annex “I”** and made as an integral part hereof;

**WHEREAS**, within the set deadline of 10 October 2023 at 03:00 P.M., four (4) quotations were received by the BAC Secretariat, to wit;

1. Limkaco Industries, Inc.;
2. Tent King Corporation;
3. RFMARU Industrial Design and Fabrication; and
4. SIB Consumer Goods Trading.

The quotations received are hereto attached and marked as **Annex “J1 to J4”**, and made integral parts hereof;

NOW, THEREFORE, the Bids and Awards Committee, hereby **RESOLVES** to recommend to the Commission, through Chairperson Karlo A. B. Nograles as the Head of the Procuring Entity, for consideration and approval, the award of contract to the **RFMARU Industrial Design and Fabrication** as the Lowest Calculated and Responsive Bidder for the **Supply, Delivery, and Installation of Two (2) Units Heavy-Duty Collapsible Tent** amounting to **Eighty-Eight Thousand Pesos (Php88,000.00)**, inclusive of all applicable taxes.


