RECOMMENDING THE AWARD OF CONTRACT TO *UPLITE GENERAL MERCHANDISE FOR THE SUPPLY AND DELIVERY OF TEN (10) UNITS SOLAR FLOOD LIGHT WATERPROOF* UNDER ABSTRACT OF QUOTATIONS NO. 2023-014 - NEGOTIATED PROCUREMENT – SMALL VALUE PROCUREMENT (NP-SVP)

BAC RESOLUTION No. 2023-014 (AMP)¹

WHEREAS, the Civil Service Commission – Office for Financial and Assets Management – Building and Grounds Management Division (CSC-OFAM-BGMD) submitted Purchase Request (PR) No. 2023-02-0130 for the **Supply and Delivery of Ten (10) units Solar Flood Light Waterproof** under mode of procurement **Negotiated Procurement – Small Value Procurement (NP-SVP)** with an Approved Budget for the Contract (ABC) amounting to Sixty Thousand Pesos (PhP60,000.00). The 2023 approved Annual Procurement Plan (APP) is likewise submitted. Copy of 2023 APP and PR are attached and marked as **Annexes “A” and “B”** respectively, and are made as integral parts hereof;

WHEREAS, under the Negotiated Procurement – Small Value Procurement of Annex “H” of the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184 or the Government Procurement Reform Act reads: *“The BAC shall prepare and send RFQs/RFPs to at least three (3) suppliers, contractors or consultants of known qualifications. This, notwithstanding, those who responded through any of the required postings shall be allowed to participate. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof;*

WHEREAS, the CSC Bids and Awards Committee (BAC), through the BAC Secretariat posted a Request for Quotation (RFQ) No. 2023-014 NP-SVP at the Philippine Government Electronic Procurement System (PhilGEPS) and CSC Website starting 03 February 2023². The RFQ and proof of posting are attached and marked as **Annexes “C”, “D” and “E”** respectively, and are made as integral parts hereof;

WHEREAS, the OFAM-PMD likewise, conducted canvass of prices by sending RFQ No. 2023-014 NP-SVP to forty-three (43) prospective suppliers/service providers. The proof of invitation is attached, marked as **Annex “F”** and made as an integral part hereof;

WHEREAS, within the set deadline of 10 February 2023 at 03:00 P.M., three (3) quotations were received by the BAC Secretariat, to wit;

1. Uplite General Merchandise;
2. 8 Dimensions Trading & Supplies, Inc.;
3. Lucky Magic Light Trading Co.

WHEREAS, upon evaluation of bid/quotation, the CSC-BAC found that **Uplite General Merchandise** registered under PhilGEPS Registration No. 2018-244550, offered the lowest calculated and responsive bid amounting to Forty-Eight Thousand Pesos (Php48,000.00). A copy of the Abstract of Quotation is hereto attached and marked as **Annex "G"** and made as an integral part hereof;

WHEREAS, under the procedure on Negotiated Procurement – Small Value Procurement of Annex "H" of the RIRR of Republic Act No. 9184 or the Government Procurement Reform Act reads: "*the BAC shall recommend to the HoPE the award of contract in favor of the supplier or contractor with the Single or Lowest Calculated and Responsive Quotation.*";




