**RECOMMENDING THE AWARD OF CONTRACT TO *CARSAN AUTO SERVICE AND TRADING CENTER FOR THE REPLACEMENT OF DEFECTIVE CLUTCH COMPONENTS OF UTILITY VEHICLE TOYOTA VIOS* UNDER ABSTRACT OF QUOTATIONS NO. 2023-017 - NEGOTIATED PROCUREMENT – SMALL VALUE PROCUREMENT (NP-SVP)**

**BAC RESOLUTION No. 2023-017 (AMP)<sup>1</sup>**

**WHEREAS**, the Civil Service Commission – Office for Financial and Assets Management – General Service Division (CSC-OFAM-GSD) submitted Purchase Request (PR) No. 2023-01-0033 for the **Replacement of Defective Clutch Components of Utility Vehicle Toyota Vios** under mode of procurement **Negotiated Procurement – Small Value Procurement (NP-SVP)** with an Approved Budget for the Contract (ABC) amounting to Sixty Thousand Pesos (PhP60,000.00). The 2023 approved Annual Procurement Plan (APP) and Vehicle Condition Report are likewise submitted. Copy of 2023 APP, VCR and PR are attached and marked as **Annexes “A”, “B” and “C”** respectively, and are made as integral parts hereof;

**WHEREAS**, under the Negotiated Procurement – Small Value Procurement of Annex “H” of the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184 or the Government Procurement Reform Act reads: *“The BAC shall prepare and send RFQs/RFPs to at least three (3) suppliers, contractors or consultants of known qualifications. This, notwithstanding, those who responded through any of the required postings shall be allowed to participate. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof;*

**WHEREAS**, the CSC Bids and Awards Committee (BAC), through the BAC Secretariat posted a Request for Quotation (RFQ) No. 2023-017 NP-SVP at the Philippine Government Electronic Procurement System (PhilGEPS) and CSC Website starting 07 February 2023<sup>2</sup>. The RFQ and proof of posting are attached and marked as **Annexes “D”, “E” and “F”** respectively, and are made as integral parts hereof;

**WHEREAS**, the OFAM-PMD likewise, conducted canvass of prices by sending RFQ No. 2023-017 NP-SVP to twenty (20) prospective suppliers/service providers. The proof of invitation is attached, marked as **Annex “G”** and made as an integral part hereof;

**WHEREAS**, within the set deadline of 16 February 2023 at 03:00 P.M., two (2) quotations were received by the BAC Secretariat, to wit;

1. Markpower Enterprises; and
2. Carsan Auto Service and Trading Center.

**WHEREAS**, upon evaluation of bid/quotation, the CSC-BAC found that **Carsan Auto Service and Trading Center** registered under PhilGEPS Registration No. 20070816083472239245, offered the lowest calculated and responsive bid amounting to Fifty-Five Thousand Pesos (PhP55,000.00). A copy of the Abstract of Quotation is hereto attached and marked as **Annex "H"** and made as an integral part hereof;

**WHEREAS**, under the procedure on Negotiated Procurement – Small Value Procurement of Annex "H" of the RIRR of Republic Act No. 9184 or the Government Procurement Reform Act reads: "*the BAC shall recommend to the HoPE the award of contract in favor of the supplier or contractor with the Single or Lowest Calculated and Responsive Quotation.*";


**NOW, THEREFORE**, the Bids and Awards Committee, hereby **RESOLVES** to recommend to the Commission through Chairperson Karlo A. B. Nograles as the Head of the Procuring Entity for consideration and approval, the award of contract to the **Carsan Auto Service and Trading Center** as the Lowest Calculated and Responsive Bidder for the **Replacement of Defective Clutch Components of Utility Vehicle Toyota Vios** amounting to *Fifty-Five Thousand Pesos (PhP55,000.00)* inclusive of all applicable taxes.
