**RECOMMENDING THE AWARD OF CONTRACT TO *WILCON DEPOT, INC.* FOR THE SUPPLY AND DELIVERY OF TILES FOR THE RENOVATION OF THE OFFICE OF ASSISTANT COMMISSIONER RONQUILLO (FORMER CIVIL SERVICE INSTITUTE (CSI) TRAINING ROOM) UNDER ABSTRACT OF QUOTATIONS NO. 2023-043 - NEGOTIATED PROCUREMENT – SMALL VALUE PROCUREMENT (NP-SVP)**

**BAC RESOLUTION No. 2023-043 (AMP)<sup>1</sup>**

**WHEREAS**, the Civil Service Commission – Office for Financial and Assets Management – Building and Grounds Management Division (CSC-OFAM-BGMD) submitted Purchase Request (PR) No. 2023-03-0361 for the *Supply and Delivery of Tiles for the Renovation of the Office of Assistant Commissioner Ronquillo (Former Civil Service Institute (CSI) Training Room)* under mode of procurement **Negotiated Procurement – Small Value Procurement (NP-SVP)** with an Approved Budget for the Contract (ABC) amounting to One Hundred Forty One Thousand One Hundred Twenty Pesos (PhP141,120.00). The 2023 approved Annual Procurement Plan (APP) is likewise submitted. Copy of 2023 APP, PR and Floor Plan are attached and marked as **Annexes “A”, “B” and “C”** respectively, and are made as integral parts hereof;

**WHEREAS**, under the Negotiated Procurement – Small Value Procurement (NP-SVP) of Annex “H” of the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184 or the Government Procurement Reform Act reads: “*The BAC shall prepare and send RFQs/RFPs to at least three (3) suppliers, contractors or consultants of known qualifications. This, notwithstanding, those who responded through any of the required postings shall be allowed to participate. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof;*”

**WHEREAS**, the CSC Bids and Awards Committee (BAC), through the BAC Secretariat posted a Request for Quotation (RFQ) No. 2023-043 NP-SVP at the Philippine Government Electronic Procurement System (PhilGEPS), CSC Website starting and conspicuous places within CSC premises starting 24 March 2023<sup>2</sup>. The RFQ and proof of posting are attached and marked as **Annexes “D”, “E”, “F” and “G”** respectively, and are made as integral parts hereof;

**WHEREAS**, the OFAM-PMD likewise, conducted canvass of prices by sending RFQ No. 2023-043 NP-SVP to thirty-five (35) prospective suppliers/service providers. The proof of invitation is attached, marked as **Annex “H”** and made as an integral part hereof;

**WHEREAS**, within the set deadline of 29 March 2023 at 03:00 P.M., only quotation from **Wilcon Depot, Inc.** was received by the BAC Secretariat. The quotation received is hereto attached and marked as **Annex “I”**, and made as an integral part hereof;

**WHEREAS**, upon evaluation of bid/quotation, the CSC-BAC found that **Wilcon Depot, Inc.** registered under PhilGEPS Registration No. 2015-145734, offered the single calculated and responsive bid amounting to Ninety-One Thousand Seven Hundred Seventy-Two Pesos and Fifty Centavos (Php91,772.50). A copy of the Abstract of Quotation is hereto attached and marked as **Annex "J"** and made as an integral part hereof;

**WHEREAS**, NP-SVP of Annex "H" of the RIRR of Republic Act No. 9184 or the Government Procurement Reform Act reads: "*the BAC shall recommend to the HoPE the award of contract in favor of the supplier or contractor with the Single or Lowest Calculated and Responsive Quotation.*";

**NOW, THEREFORE**, the Bids and Awards Committee hereby **RESOLVES** to recommend to the Commission, through Chairperson Karlo A. B. Nograles as the Head of the Procuring Entity, for consideration and approval, the award of contract to the **Wilcon Depot, Inc.** as the Single Calculated and Responsive Bidder for the *Supply and Delivery of Tiles for the Renovation of the Office of Assistant Commissioner Ronquillo (Former Civil Service Institute (CSI) Training Room)* amounting to *Ninety-One Thousand Seven Hundred Seventy-Two Pesos and Fifty Centavos (Php91,772.50)* inclusive of all applicable taxes.
